In Russian Federation tax deductions apply to:

- charity donations
- payments for education
- payments for medical treatments and medicines
- private pension insurance or life insurance contributions
- work pension contributions

Read the short descriptions of the life situations of six different people living in Russia and match each of them with the type of a tax deduction they're eligible for. Find one person who can't apply for a tax deduction.

- 1. Rita is 45 years old and works officially for a big international company. Her 17-yearold son is a student at Higher School of Economics in Moscow. He is an openminded, easy-going person but it's very difficult for him to concentrate. He failed his final exams in high school and Rita has to pay for her son's education.
- 2. Tanya and Vlad have got divorced after 7 years of marriage. Vlad thought Tanya is too talkative while Tanya was convinced that Vlad is being too lazy. They have a common 5-year-old child and Vlad pays for the maintenance of his ex-spouse and son.
- 3. Denis spends a lot of time outdoors, he adores nature and loves wild animals. Last 4 years he has been supporting the WWF fund. He donates 2000 rubles every month. He's optimistic and believes he can make a difference by his contribution.



- 4. Arthur used to be an extremely energetic and hot-tempered man but after a recent car accident he experiences severe back pain and partial immobility. He needs to undergo an expensive medical treatment next month. He also spends a sufficient sum of money weekly to buy painkillers for his back pain.
- 5. Marta is a cautious person. Last year she decided to purchase life insurance for her husband and herself.

What should people in Russia do to apply for tax deduction? Put the actions in the right order:

- a. Fill in the tax deduction form.
- b. Submit the application form and the required documents through your local tax authority.
- c. Collect the documents confirming your eligibility.

Did you know you can write a complaint to Central Bank about this incident?

Let me show you how!

Which bank was it?

When did it happen?

Do you remember the name of the bank assistant and the address of the branch? Do you have a local telephone number?

# Example:

A: Hi! How's your day?

B: Not perfect, actually. I've tried to open a bank account and get a credit card today but couldn't do it.

A: What happened?

B: The assistant there was trying to convince me to buy an additional insurance from the bank and was awfully persistent. I had to leave the bank office and felt extremely frustrated.

A: That's a **common trick** they use to boost their sales and that's annoying! You can write a **complaint letter** to Central Bank about this incident.

B: Do you think it's necessary?

A: You should **stand up for your rights!** I can help you with this.

B: Ok, let's do it.

A: We have to go to Central Bank's official website and fill in the form. Which bank was it?

B: It's called N. The address is Trubnaya Str., 8.

A: So, we'll choose "Bank products and services" as a category and "Consumer loans" as a subcategory. The next field is for a short description of the situation. Do you have a local telephone number?

B: Yes, it's +7 989 999 999.

A: Done! I'm glad we did it because they have no right to treat their clients this way.

B: I can't agree more! Thank you for helping me!
